The Household Hazardous Waste Collection is a free service for Roscommon County residents/landlords and is coordinated by the Roscommon County Solid Waste Recycling Committee.

They will accept any items marked Caution, Corrosive, Dangerous, Flammable, Poison, Reactive, Toxic or Warning.

They WILL NOT accept toner printer cartridges, boat shrink wrap, latex (water-based) paints, explosives, bombs, fireworks, propane tanks, large appliances, Styrofoam peanuts, building materials or any kind of empty containers. They WILL

ACCEPT aerosols, anti-freeze, auto liquids, cleaners, fertilizers, corrosives, florescent light bulbs, glues, herbicides, medicines/sharps,

mercury-containing items, oil-based paints, pesticides, smoke alarms/detectors and solvents. Please stay in your vehicles and wait for a volunteer to unload your items. There will be seven stations located at the site. The Roscommon County Road Commission is located at 820 E. West Branch Road in Prudenville. DRUG DROP BOX
