- Group email on 10/09/2020 approving purchase of batter/charger separately for the RYOBI vacuum Trunk or Treat prize.
- Invoice from Higgins Lake-Roscommon Chamber of Commerce for annual non-profit membership dues of \$50.00. Motion to pay annual membership fee of \$50 to HLRCC by Bob Barber. Support by Mike Briggs, all in favor, none opposed, motion carried.
- Award letter from RCCF (The Roscommon County Kellogg Youth Fund) for \$1,500.00 grant for Kids Helping Kids Program. Grant award letter was signed and returned on 10/27/2020.

OLD BUSINESS

- SWAC Stuffed Animal Fundraiser Update (Julie) Still selling the turtles from the Twp. Hall, GTPD and The Bird & The Bear Grill. We have a net profit raised so far of \$1,089.53 for this project (all funds go to SWAC). Suggested that maybe Higgins Lake Hardware (west side of lake) may be willing to sell from their business also.
- Trunk or Treat went pretty well, all things COVID considered, with the change of venue and style of event (drive-thru). 247 vehicles were counted that visited and voted on their favorite trunks. 17 trunks participated (5 that were pre-registered did not show up). Estimated

- approximately 800 bags of candy were handed out. Will have a TorT debrief meeting on Friday, 11/13/2020 at 1:00 p.m. at the P.D. to review event.
- Scrap Metal project has been closed for the year. This season has raised almost \$1,100.00. Thank you to Stan and Dave for their diligent work of sorting and hauling the scrap metal to the recycling center. We will be addressing and starting the ordering process for a new utility trailer in February 2021.
- Resident Welcome Package Work in progress by Mike.

NEW BUSINESS

- Moving forward with Shop-With-A-Cop program for 2020. Applications have been dropped off at the school with a submission date by November 30th. Have received two in so far. Officers will still take one child per family shopping (following all COVID guidelines) however will not be taking the child to dinner afterwards. May want to provide a food gift card instead. Families will be selected at our 12/4/2020 Executive Board Meeting. Wrapping will take place on 12/21/2020 at 5:00 p.m. (with COVID guidelines adhered to) and delivery will be done by the officers on 12/22/2020 starting at 1:00 p.m. Julie will be mailing out annual donation request letters to SWAC program supporters just before Thanksgiving explaining the slight changes in the program this year.
- Received a monthly newsletter from The Lion's Den in Roscommon (faith-based rehabilitation center) seeking sponsorships for their staff/residents for Christmas. Holidays are very difficult times for the center and they are asking for \$60 per sponsorship and they shop and wrap for gifts on the resident's "wish" list. Motion by Mike Briggs to sponsor 6 residents at The Lion's Den MBTC for a total of \$360.00. Support by Eric Muszynski, all in favor, none opposed, motion carried.
- Gerrish Twp. Police/EMS/Fire/CERT have been asked again this year to do the Salvation Army Bell Ringing at Family Fare in Roscommon for one day. Everyone was willing to help out and Friday 12/11/2020 was selected as our date. A sign-up sheet will be posted in the meeting room at GTPD in one-hour blocks from 8:00 a.m. until 7:00 p.m.

CERT UPDATE (Bob Barber)

- Bob reported that there were 6 volunteers at the last Food Distribution on 10/24/2020. The next Food Truck Distributions are 11/21/2020 (4 volunteers signed up so far) and 12/10/2020.
- 6 volunteers worked the flu shot clinic held at the GTFD on 11/5/2020.
- 8 volunteers worked the Trunk or Treat event on 10/31/2020.
- Five members have signed up for flu shorts which will be given at the 11/5/2020 flu shot drive through clinic being hosted by the Health Department and held at the Gerrish Township Fire Department.
- Christmas in the Village parade will be on 12/5/2020 (tentative) however no streets will be shut down for day-time activities. (Note as of the typing for these minutes on 11/17/2020 the Light Parade scheduled for 12/5/2020 HAS BEEN CANCELLED).
- CERT Trailer will need a replacement vent cover in the spring. The current cover has a crack that has been temporarily repaired and the trailer will be stored indoors at Fire Station #3 for the winter so it should not be a problem.
- Suggestion to add a standard tool box to the CERT Trailer. Mike Briggs has volunteered to garner information for tools/box purchase.
- Bob shared that at the last food distribution behind the County Building, he was approached by Sheriff Stern who complemented him and our Gerrish CERT team on the organization and professionalism of the team
